As a County we now have 337 people needing to completed Level 1 training and 265 needing to complete Level 2 and 15 people needing to completed Level 3 for their roles and a further 28 units with no level 3 safe space. We know that you have been working hard to support these volunteers and units but with just under 2 months left before compliance day we are very concerned we will lose these volunteers and have units that will be unable to meet.
